

General rules and agreement for 2006 dove shoots

- 1. Follow all Georgia game laws.
- 2. No shooting of low birds (general rule keep gun at 10 and 2 o'clock), (do not aim below the tree line).
- 3. No drinking before or during shoot.
- 4. Stay on stand until moved by manager.
- 5. All under age hunters must stay with adult at all times.
- 6. Guns will remain unloaded with the action open until reaching the stand. Loaded guns are only allowed at the stand.
- 7. Do not drive on the field. Transportation will be provided to the field.
- 8. Provide your own shells. Drinks will be provided during the shoot. Please bring your own as well.
- 9. Please leave the field as you found it. Take all shotgun shells and trash with you.
- 10. Hunters need to arrive at the lodge on opening day buy 10am.

Things to bring. Sunscreen, cooler, ice, drinks and snacks, stool, bug spray, ear plugs, eye protection, large brim hat or cap, hunting license, blind, and at least four boxes of shells.

To reserve a stand on field for opening day:

Option 1 before August 25 2006 is \$100.00.

Option 2 After August 25 \$110.00.

Option 3 50% deposit of \$62.00 is required to reserve a stand on field. The remainder is due upon arrival. People wanting to cancel hunt 30 days or less before hunt date will be billed the remaining amount of \$62.00.

To reserve a stand on field after opening day: The cost per stand is \$100.00. A \$50.00 deposit per stand will reserve stand then \$50.00 upon arrival. People wanting to cancel hunt 30 days or less before hunt date will be billed the remaining amount of \$50.00
